***DECK-SEEDED SWIMMERS MUST CHECK IN**

Electronic Timing will be used

ELIGIBILITY. Open to any **current** USMS registered swimmer or a foreign swimmer with a valid travel permit. SPMA swimmers are encouraged to submit their registration application with the submitted entry card, if NOT currently registered. On-deck registration is permitted.

AFFILIATION. A swimmer's affiliation as stated on the consolidated entry card, if valid as of the first day of the meet, will apply throughout the meet. However, swimmers may unattach at any time.

SEEDING. All events will be deck seeded slowest to fastest, by entered time, ages and sexes combined. Check-in is not required in order to be deck-seeded, however swimmers **MUST** check in to swim the **1500 M. Freestyle and the 400 M. Freestyle**.

SUBMITTED TIMES. Please enter your best time, a reasonable estimate or a workout time. All times must be submitted on a SPMA consolidated entry card or a copy of a SPMA consolidated entry card (both sides). Do not mail in this entry information sheet.

RELAYS. All relays will be deck-entered (\$2.00 per relay due upon entry). All relays must be submitted on SPMA relay forms which will be available at the meet. Incorrect or illegible entries will be rejected. For each relay swimmer that is not entered in individual events, a fee of \$5.00 and a signed liability release must be submitted with the relay entry.

AWARDS. **INDIVIDUAL** - SPMA ribbons to places 1-3. **RELAY** - SPMA ribbons to first place.

ENTRY FEES. \$20.00 per swimmer flat fee. **Deck entries allowed** for total of \$30.00 (includes \$10.00 late fee).
